### Resolution passed in international conference held in Kathmandu, Nepal on 17<sup>th</sup> February, 2024

A conference of activists held in Kathmandu, Nepal during 16<sup>th</sup> Edition of World Social Forum, WSF Nepal 2024. The organizer of the conference was Mission for Global Change, MGC; a Public Charitable Trust of India, registered in Lucknow. A conference was held on 17th February, 2024; at 2:00 p.m. to 4:00 p.m. in Nepal Law College, Room No.- 102 of Block- C, at 1st floor. People from different countries, including Nepal, India, Bangladesh, Pakistan, Sri Lanka etc. participated in the conference.

#### The following resolutions were passed:

1. It is resolved that the undersigned, the aspirants of International and Global Rights for safety and security of life and property from Wars and from Climatic Hazards agreed to form an Organisation/ Body/Government to effectively ensure peace and Goodwill amongst all Nation States.
2. It is also resolved that the forum will ensure to provide equal opportunity to all human beings to avail participation in Global Growth, without any political, social and economic discriminations.
3. It is also resolved that this proposal and resolution shall be sent to all the executive Heads of all the Countries of South Asia and of the whole World requesting each Country to place the same for consideration at the appropriate level/forum and for vetting the same with appropriate modifications and suggestions, if any, so that a consensus can be arrived at and a final Constitution for the Union of South Asian Countries and for the union of countries of entire World can be adopted by head of the nations.
4. It is also resolved that a Draft of the Constitution of the Union of South Asian countries and also of the World/Earth shall be drafted within a period of 6 months from the date of this resolution. It is further resolved that the same shall also be sent to all the executive Heads of all the Nation States requesting each Country to place the same for consideration at the appropriate level/forum and for vetting the same with appropriate modifications and suggestions, if any, so that a consensus can be arrived at and a final Constitution can be adopted by all the Nations within a period to be specified later.
5. It is also resolved that till the final Constitution is adopted by all the Nation states, an Interim Parliament and an Interim Government of South Asian countries and that of the whole world shall start functioning after a lapse of a period of six months from the date of adoption of this resolution and/or from the last date when communication has been sent to the executive Heads of the Nations, whichever is later.
