- iii. To comply article 51 of Indian constitution by getting treaties for the formation of Union of South Asian Countries and Union of all nations of the world;
- iv. To get international treaties to transform United Nations, UNO into United National Government, UNG for getting adequate share of India in the sovereignty of the world, to apply the rule of democratic laws at world level also and to encourage settlement of international disputes;
- v. To use the whole world by the ancient teachings of India known as VASUDHAIV KUTUMBAKAM and non violence.

Respected Madam,

The submissions of undersigned are as under:

1. That the Mission for Global Change, in short "MGC" is a public charitable trust. This trust is registered under Indian Trust Act 1882. After long deliberations, it is concluded by the volunteers of MGC to form interim parliaments and interim governments as the organs of this charitable organization in first phase and hand over these organs/organizations to concerned sovereign nations of the world in second phase. Looking the objective of prevention of wars and grant of International and Global Rights; it is concluded to form above said interim organizations at International and Global level on 24th October, 2024.

 - A. Kindly instruct the Ministry of External Affairs or the office of the Ambassador Extraordinary and Plenipotentiary Permanent Representative in Permanent Mission of Republic of India to the United Nations to forward the attached circular to concern organs/departments of United Nations and to the head of the nation states globally in order to have treaties to grant the International and Global Rights to domestic citizens of India and abroad.
 - B. Constitute a competent Ministry/department under the government of Union of India to work on above said international treaties;
 - C. Arrange for the meeting with a delegation from Mission for Global Change, MGC to present its points directly before Your Excellency one to one meeting and resolve the doubts.
 - D. Organize an international conference on the proposals of this representation and invite our representative/delegation of MGC to speak.
 - E. Provide government's support to the Mission for Global Change, MGC through financial grants, logistics and infrastructure to foster global consensus on the proposed treaties.
 - F. Send appropriate suggestions and/or support by resources to MGC; on initiative of MGC to form above said super-national parliaments and respective interim governments to facilitate the above said global consensus; in case due to traditional working practices and various compulsions, the nation states of the world are seen unable to form above said governments and Parliaments within 6 months before 17 August 2024 or before the United Nations Day, 24th October 2024.
4. That the MGC wish to not take initiative to form above said super-national parliaments and respective interim governments; if the Government of India informs the undersigned that the Government of India has taken satisfactory action already in this regard and hence therefore this initiative is useless and not acceptable to government of India.
5. That the MGC wishes to form the above said Interim Parliaments and Governments and wishes to hand over these organizations / Interim Parliaments and Governments to concerned nation states as soon as possible to run these organizations as full fledged sovereign Parliament and Government. For this purpose the MGC wishes to draft the treaties and present the draft before the government of India and before the government of other nations to ratify the same.

PRAYER

The prayers of undersigned to H. Excellency are as follows:

- a) Send para wise reply and action taken report of the Government of Union of India on representation dated 10.04.2024 within 30 days.
- b) Issue directions or to extend the guidance and /or support to Mission for Global Change, MGC in connection to initiative of MGC for the formation of Interim Parliament and Interim Government for South Asian Countries and of all nations of the world at International and world level respectively, if above said treaties are not ratified by nations before 24th October, 2024.
- c) Issue directions within 30 days to concerned ministries and department(s) of Government of Union of India:
 - (a) To take action on the representation of undersigned dated 10.04.2024;
 - (b) To inform please with reasons, if the proposed initiative of MGC to form proposed super-national Interim parliaments and respective interim governments at international and global level in order to grant International and Global Rights (as defined in the representation dated 10th April, 2024) to needy citizens of India is not acceptable to Government of India. Otherwise the initiative will deem to be acceptable by the Government of India in Toto as a step taken by the civil society.
- d) Take other action(s) appropriate in fact and circumstances to promote world peace and security and to grant International and Global Rights to Indian citizens.

Dear Madam,

The submissions of undersigned are as under:

1. That the undersigned is aware that it is general practice of offices of diplomats that such representations received from citizens of own/other countries are neither acknowledged nor replied. But in the given world order the inhabitants of this earth, like the undersigned and his associates, have no other option to urge for safety and security of self and of surroundings. Because in the present age of global communication, Global economy and borderless world market, the right of safety and security of domestic citizens cannot be protected and guaranteed only by the government of nation states. War disasters happened/happening in Ukraine, Israel and Gaza are recent glaring examples. Due to lack of effective mechanism to prevent and stop such wars immediately; the recurrence of such war will happen again and again in future. The unbearable sufferings of civilians caused by the wars in these countries are realized by the head of nations but due to structural compulsion they are bound to watch this man-made disaster helplessly. Due to this horrible and helpless situation the civilians of all countries of the world are gripped with fear of possibilities of bombardment and missiles on their houses in the coming days. If the United Nations is helpless to stop wars due to its structural reasons and helplessly witnessing the killings of multi thousand civilians of various countries, if head of nations are helpless and if the citizens of other countries and political thinkers of world are not empowered to come up with suggest and resolutions to the head of nations and United Nations; then the traditional old pattern ways based on the present political structure with so much of limitations of citizens, civil societies and political thinkers and conventional practices of diplomacy will lead to further disaster and to save the World and the people - this pattern and the old pattern is bound to be broken. Thus realizing the duty for humanity; the undersigned has no other option to convey his findings to all heads of nations to maintain peace, enhance growth, reform the obsolete world polity and to ensure the participation of marginalized sections of society in power and global prosperity.

2. That due to global competition to minimize production cost through automation, the governments of nation states are no longer capable of giving employment to domestic citizens and thus no longer capable of eliminating poverty and of controlling unhealthy inequalities. Hence therefore grant of International and Global Rights (Attached as Annexure No.-04) to all citizens of all nation states is the only way out left and most effective way at present. Without creation of new super-national government like agencies; the protection and guarantee of above said International and Global Rights is not possible.
3. That we all are aware that the technology of the Internet has affected the polity and economy very deeply. It has given a big boost to the already existing interrelationships and interdependence amongst the citizens of the countries. In this contemporary age, some multinational corporations have become more powerful than the governments of many countries in the world. The formation and stability of governments in all the countries, where the multiparty democracy is in practice, are now influenced more by multinational corporations and internet-driven media than by the general will and public opinion. In this situation the governments have become helpless before the corporations.
4. That due to above said reasons, it has become impossible for the governments of countries to protect and nurture the political, economic, international and global interests of the majority of the citizens of countries. Due to this compulsion of the governments of nation states, the traditional definition of sovereignty have now become political superstition. It is no longer possible to define sovereignty by traditional norms. In this regard, the definition of political thinkers like T.H. Green has now become more relevant to sovereignty.
5. That hence therefore, it has become indispensable to carry out structural reforms of the United Nations by ratifying appropriate international treaties without delay. So that it could be possible:
 - a. To promote the proper and inclusive development of our country;
 - b. To protect and enhance the international and global interests and rights of our domestic citizens;
 - c. To protect our country and citizens from environmental hazards and from international economic exploitations;
 - d. To prevent the possibility of a third world war and to ensure global peace;
6. That to avail above said benefits by countries and their domestic citizens, formation of some government like vertical institutions is required to grant and protect the international and global rights of citizens of all nation states. International Rights may be granted and protected by the union of neighboring countries but the Government of the whole earth is required for the grant and protection of global rights. In order to grant various fundamental rights to domestic citizens a historic achievement was attained when separation (horizontal) of state power was done in 17th and 18th centuries. Today the vertical separation of state power has become indispensable to grant and protect the international and global rights of domestic citizens of all nation states.
7. That hence, it has become the urgent need of the hour:
 - a. To have international treaties with our neighboring countries like- Bangladesh, Bhutan, Burma, Maldives, Nepal, Sri Lanka, Pakistan, etc. to form a union similar to the European Union;
 - b. To have international treaties to form a government of our East hemisphere with our neighboring Union(s); and,
 - c. To have international treaties to form a United National Government, UNG, like competent institution of the whole earth by reforming the structure of the United Nations.
8. The undersigned had been requesting the nation states since 2006 but the nation states are neither rejecting not translating the proposals of undersigned into action. Due to this delay, the whole world is being compelled to witness helplessly the war disaster in Ukraine, Israel and in Gaza. Hence, the undersigned and associates of his organization have passed a resolution in the International Conference of World Social Forum which was held in Kathmandu, Nepal from 15th to 19th February 2024 and it was resolved to send the resolutions passed, to all the Head of Nations requesting and

appealing to help the Mission for Global Change, MGC to form vertical parliaments and governments suggested in the instant representation. It was further resolved that if the resolutions are not translated into action by the nations within 6 months/ before the United Nations Day, 24th October 2024, the Mission for Global Change should form the above said interim parliaments and interim governments. The copy of the passed resolutions is attached herewith along with the concept note for kind perusal of office of H. Excellency.

9. The undersigned is sending the instant representation to head of nations expecting the same result what is seen in 2006 and 2015. Therefore, the responsibility of the Indian state increases greatly, because both India's culture and DNA are imbued with the ideal of Vasudhaiva Kutumbakam. India also has a strong leadership at this time. For whom this mission is not impossible. Hence therefore the circular attached herewith may be forwarded to all head of nations with request to initiate the international conferences for drafting and ratifying the required international treaties. The government of India may send this request to nations in other convincing language, if any.


