Subject: Invitation to Inaugurate the International Conference on the Global Agreement on Peace & Participation (GAPP) on 24th October 2024 in New Delhi.

Respected Sir,

It is with great pleasure that I congratulate you on your third consecutive term as the Prime Minister of India.

On behalf of the Mission for Global Change (MGC), I am writing to request your esteemed presence to inaugurate the International Conference on the Global Agreement on Peace & Participation (GAPP) on 24th October 2024 in New Delhi. Your participation would be a significant step toward realizing the vision of 'Akhand Bharat' and 'Vasudhaiva Kutumbakam,' ideals cherished by our ancestors and luminaries like Shree Aurobindo, Rabindranath Tagore, Deendayal Upadhyay, Ram Manohar Lohia, and our first Prime Minister, Jawaharlal Nehru. Article 51 of Indian constitution also directs the Indian state to work in this direction.

We propose that your Excellency may consider taking on the role of the first President of a proposed Union of South Asian countries akin to European Union. This initiative could pave the way for the establishment of a United National Government (UNG) by introducing reforms within the charter of United Nations. The envisioned UNG would enhance cooperation between individuals and nations and help prevent conflicts among governments and international alliances. This initiative will undoubtedly address longstanding global politico-economic challenges faced by our nation, such as poverty, education, malnutrition, public health, unemployment, international corruption, terrorism, environmental and ecological issues, international conflicts, the threat of a third world war, global pandemic, and more.

Mission for Global Change (MGC) is a public charitable trust dedicated to fostering and nurturing trust and love on a global scale. We view each human and government as vital organs of our shared mother Earth. The charter of the proposed UNG would be robust enough to address bilateral and multilateral conflicts, ensuring peace through diplomacy rather than force, as is often the case today. The establishment of a Democratic Global Parliament, constituted by local representatives from across the world, would further empower this global body and help to achieve these objectives. The proposed Global Parliament and UNG would be instrumental in promoting global peace and participation, supported by international treaties and a collective understanding of global unity.

Given the limitations of the current United Nations structure, which lacks the authority to enforce peace or grant international rights to the world's inhabitants, the creation of the UNG has become imperative.

In pursuit of this goal, we have also engaged with Shri Arjun Ram Meghwal Ji, Minister of Law and Justice, and spoken with Shri Kirti Vardhan Singh Ji, Minister of State for External Affairs, to bring the legal and other aspects of this matter to the attention of the Government and to seek the association and blessings of the Government of India for this initiative. We have submitted two representations, dated 10/04/2024 and 05/07/2024, to the Hon'ble President of India, requesting that copies be forwarded to all nations to build global consensus on this matter. The matter is under consideration before Ministry of External Affairs at the moment.

In light of these efforts, the Mission for Global Change has established a new organization, the Global Agreement on Participation and Peace (GAPP). GAPP plans to announce the formation of the Indian Chapter of the Interim World Parliament and the Interim Parliament of the South Asian Union during the international conference in New Delhi on United Nations Day, 24th October 2024. This event will serve as a platform to facilitate international treaties necessary for the future establishment of the UNG and Global Parliament.

We earnestly request your kind response to this initiative and hope that you will honor us by inaugurating this important conference. Your presence would be a great encouragement to all of us working towards world peace and the realization of international and global rights.
